On amending the Rules for crossing the state border by citizens of Ukraine

The Cabinet of Ministers of Ukraine decrees:

To amend [the Rules for Crossing the State Border by Citizens of Ukraine](#), approved by Resolution of the Cabinet of Ministers of Ukraine No. 57 dated January 27, 1995 (Collection of Resolutions of Ukraine, 1995, No. 4, p. 92; Official Gazette of Ukraine, 2010, No. 65, p. 2239; 2023, No. 48, p. 2648), as attached.

CHANGE,

[to the Rules for Crossing the State Border by Citizens of Ukraine](#)

To supplement [the Rules](#) with paragraph 2¹⁹ as follows:

“2¹⁹. In the event of the introduction of martial law on the territory of Ukraine, male citizens of Ukraine aged 18 to 22 years who are pursuing a bachelor's (master's) degree in medicine, pharmacy or veterinary medicine in a full-time form of education in higher education institutions of Ukraine of state or municipal ownership and who, in accordance with the [Procedure for the implementation of the right to academic mobility](#), approved by the

Resolution of the Cabinet of Ministers of Ukraine of August 12, 2015, No. 579 (Official Gazette of Ukraine, 2015, No. 66, p. 2183; 2022), shall be allowed to cross the state border,

Confirmation documents for students of higher education institutions of Ukraine of state or municipal ownership who are participants in educational academic mobility programs are

-a certificate from a higher education institution of Ukraine on the referral of a participant of the educational academic mobility program to study at a foreign educational institution, indicating the basis for cooperation, the duration of the academic semester abroad, the absence of negative grades and facts of retakes of tests and exams according to the results of the last two semesters (six months) and confirmation of the level of proficiency of the applicant in the language of instruction in a foreign educational institution;

-a copy of the academic mobility agreement certified by the educational institution of Ukraine in the prescribed manner;

-e-ticket of the student (pupil), verified by means of the Diia Portal using electronic devices by reading or entering a unique electronic identifier;

-military registration documents with the relevant marks of the district (united district), city (district in cities, united city) territorial center for recruitment and social support.

Students of higher education institutions of Ukraine of state or municipal ownership who are participants in educational, academic mobility programs may continuously stay abroad for no more than the duration of the academic semester.”
